### REGULATIONS \*

- (4) (I) For success at the S.S. Examination it shall be compulsory to pass in all subjects except in English and SUPW.
- (II) Under Social Science subject it shall be compulsory to pass in all papers separately.
- (III) For Science subjects like Physics, Chemistry and Biology an examinee is required to pass in Theory and Practical examination together obtaining at least 15 marks out of 50 in each subject.
- (IV) English and SUPW are compulsory subjects and obligatory for all to appear in these subjects. However, the marks obtained in English and SUPW shall not be included in the aggregate for the purpose of determining the division secured. In SUPW only grade will be awarded on the basis of marks obtained by the examinee.
- (V) The division of an examinee shall be decided on the marks obtained in 5 subjects e.g. language, math, science, social science and compulsory optional with a total of 700 marks.
- (VI) Examinee obtaining 420 or more marks in the aggregate shall be placed in the First division and those obtaining 315 marks or more but less than 420 marks shall be placed in the Second division. Those securing 210 marks or more but less than 315 marks shall be placed in the Third division.
- (6) Save & except as otherwise provided, in order to pass the S.S. Examination, an examinee must obtain not less than 30 percent of the total marks in each subject and not less than 210 marks in aggregate.
- (8) An examinee for the S.S. Examination who secures pass marks in the aggregate, but fails in one subject/paper by not more than 5 percent of full marks or by not more than 3 percent of full marks in two subjects/papers shall be allowed to pass and placed in the appropriate division.
- (10) Examinee securing first division marks in the aggregate and passing in the Mother tongue and failing in one subject/paper by not more than 8 percent of full marks shall be allowed to pass and be placed in the appropriate division.



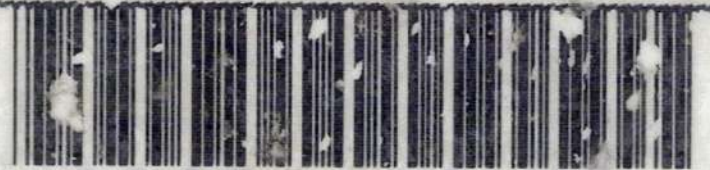
